
MEMORANDUM

In supersession of this Department Memorandum No. 1410-F(Y) dt. 08.03.2017, the existing limit of financial power of the Additional Chief Secretary / Principal Secretary / Secretary of the Information & Cultural Affairs Department to incur expenditure on account of Advertisement and Publicity is enhanced as follows:

Item of expenditure	Existing Delegated Power	Revised Delegated Power
Advertisement and publicity Expenses : a. Print Media b. Audio Visual media (electronic media) c. Hoarding d. Fairs, festivals, exhibition, state-level ceremonies	Upto ₹ 30 lakh on each occasion subject to the maximum of Budget Provision for the financial year	Upto ₹ 2 crore on each occasion subject to the maximum of Budget Provision for the financial year

All other rules and provisions laid down in FD's Notification No. 3066-F(Y) dated 11.06.2014 and other related order will remain unchanged.

Necessary amendment to the Delegation of Financial Powers Rules, 1977 will be made in due course.
