The undersigned is directed by the order of the Governor to state that the Governor is pleased to accord approval to 25 (twenty five) officers of 08 (eight) constituted state services (as per Annexure "A") to participate in the "**In-service training Programme on Public Finance Management**" in two (2) phases:

- a) **Domestic Leg** at the O.P. Jindal Global University, Haryana from **19th November, 2018 to 23rd November, 2018**, and
 - b) **Foreign Leg** at the Lee Kuan Yew School of Public Policy, Singapore **26th November, 2018 to 30th November, 2018**.
2. The participants will leave for O.P. Jindal Global University, Haryana from Netaji Subhas Chandra Bose International Airport, Kolkata on 18th November, 2018 and will return to Kolkata after completion of training programme in Singapore.
 3. All the expenses in connection with the training, logistics, accommodation, airfare, visa charges and travel for both domestic and foreign leg of the training programme will be borne by the State Government.
 4. Participants will be entitled to daily allowance @ $\frac{1}{4}$ th of US\$ 75 per diem in terms of Order No. Q/FD/695/3/2000, dated 21/09/2010 issued by Ministry of External Affairs (FD Section), Govt. of India (copy enclosed) during their stay in the Foreign Training Leg in Singapore.
 5. Cadre Controlling Authority/Head of Office of the respective state services is requested to release the participants (as per Annexure "A") for the entire period of training in India & Singapore, i.e. from 18th November, 2018 to 2nd December, 2018.


